Terms and Conditions

Consultations

Initial consultation: Adults: 1 to 1.5 hours. Up to 2 hours for GAPS.
Children: 45 mins to 1 hour. Up to 2 hours for GAPS.

Follow-up appointments: Adults: 40 minutes
Children: 30 mins
2 children: 2 x 20 mins
Parent and child: 40 mins and 20 mins

Location

All consultations will either be at Oxford, OX1 4LH or virtual (Zoom / What's App video call).

Payment

Remedies

To enable further analysis of each case, remedies will be prepared subsequent to each appointment. These can either be collected from the clinic at a later date or posted to your home. Where remedies are posted, a £2 charge will be made for postage and packing.

Remedies are provided as a package with a consultation and cannot be purchased separately except either to replace lost remedies or for an acute condition.

Advice and Emergencies

If you have any doubts in an emergency situation you should contact your GP or Casualty Department

My contact details are at the end of this document. Reasonable amounts of advice between consultations (taking me less than 10 mins) are included in the price. Longer calls will be charged pro rata at £10 per 5 minutes. I will always return a call or email as soon as I am able. If you are unable to contact me for any reason and need homeopathic advice, the Homeopathic Help Line (09065 343404) provides 9am to midnight telephone cover 365 days a year in the UK. Calls are charged at £1.53 per minute and you will be recommended a remedy to purchase from a pharmacy.

Withdrawing Medication

Many patients come with a list of pharmaceutical drugs they would like to stop taking. It is my policy that you must consult with your GP before withdrawing any medication and should never suddenly stop taking medication without at least ensuring it is safe to do so. You should contact your GP or Casualty Department for medical emergencies.

What to expect from homeopathic treatment

Homeopathy is a form of natural medicine which works with the body's energy to support and strengthen it. As with any holistic treatment, how you respond will be determined by what your body needs to do to heal itself.
